WHEREAS, the County of Somerset has prepared a contract which would provide \$19,169.00 to the Township of Montgomery for the provision of Municipal Alliance Activities for prevention of alcoholism and drug abuse, and the Township would provide a 75% match of \$14,376.75 in in-kind services, a 25% cash match of \$4,792.25 will be raised by the Municipal Alliance committee or provided by the municipality, and a copy of the proposed agreement is on file in the office of the Township Clerk

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Rocky Hill, County of Somerset, State of New Jersey that the Mayor and Clerk are hereby authorized to sign the original of this agreement in conjunction with Montgomery Township.
